

Background Information

When a customer requests a purchase of a firearm from a Federal Firearms Licensees (FFL), they have to fill out the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) Form 4473. This form is run through the National Instant Criminal Background Check System (NICS) and takes about 30 seconds to clear. However if flagged it will take an additional 3 business days to complete.

The Bipartisan Safer Communities Act will now further background check for adults 18-21 by adding an additional 7 business days to the first 3 business days if the background check is flagged

All documents or information referring to arrests, complaints, referrals, juvenile petitions, and orders. N.C. Gen. Stat. § 7B-3200(h). For anyone 17 and younger (What Are Juvenile Records?, n.d.-a)



Background Checks

A document that verifies the buyer does not have a criminal record or isn't otherwise ineligible to purchase or own a firearm (Firearms Checks (NICS), 2016)





Bipartisan Agreement

Concerning or involving two different political parties or groups making a formal decision about future action (Definition of Bipartisan, n.d.)





The act of strengthening, background checks, fight gun trafficking, passing gun restrictions and increase protections for victims of domestic violence (Gun Control Act, n.d.)
